

# AGL Aboriginal and Torres Strait Islander Scholarship

# **Terms and Conditions**

## **BACKGROUND AND SUMMARY OF KEY CONDITIONS**

The intention of this scholarship is to support Aboriginal and Torres Strait Islander students to pursue studies that otherwise might not be available to them due to prohibitive costs and challenges. The scholarship will also provide the opportunity for curriculum required placements as a Work Integrated Learning opportunity with AGL (the "donor"), internship, and graduate program placements.

If accepting an offer of this scholarship, you will:

- Notify <u>scholarships@newcastle.edu.au</u> of any changes to your circumstances such as reduced study load, change in program, or withdrawal from study that may impact your eligibility for this scholarship.
- Agree to send a thank-you message to the scholarship donor within two weeks of accepting your offer (as per the instructions in your offer email);
- Be available for a presentation ceremony during Scholars Week (usually around August/September).

The total value of this scholarship is \$20,000 for a maximum term of 4 years. Multi-year scholarships will be paid to recipients for the standard full-time duration of the original degree program, including Honours where applicable.

### **ESTABLISHMENT**

AGL's vision for reconciliation is a unified and inclusive Australia where First Nations people are respected and have equal voice, rights, and opportunities for prosperity.

We will bring our vision to life by:

- Truthfully acknowledging the past and how it has influenced where we are today.
- Working towards an inclusive future together.
- Being a trusted partner for First Nations communities in locations where we operate and are planning future projects.
- Supporting tangible economic benefits for First Nations communities through our investment in energy transition

Our approach to reconciliation is founded on our core values; our focus on creating positive social impact and building on our social license. Supporting education and employment opportunities is a key objective of AGL's reconciliation vision.

# **FUNDING ARRANGEMENT**

This is a donor-funded scholarship from AGL Energy Limited.

#### **ELIGIBILITY**

To be eligible for this scholarship, you will need to:

- be enrolled in 1<sup>st</sup> or 2<sup>nd</sup> year of either a Bachelor of Science, Mathematics, Commerce, Business, Engineering, or Information Technology
- be enrolled either full-time or part-time
- establish your Aboriginal and/or Torres Strait Islander status per the process outlined on the Wollotuka Institute's study with us page
- be an Australian citizen
- not hold another University of Newcastle donor-funded or sponsored scholarship concurrently.

# **REQUIRED DOCUMENTATION**

As part of your application, you will need to prepare:

- A personal statement (approx. 1 A4 page) outlining your academic achievements, career aspirations in the relevant area of study, and how this scholarship would assist you. This statement will cover all scholarships you are applying for.
- The application will include a free text question asking you to outline your interest in the AGL Aboriginal
  and Torres Strait Islander Scholarship and associated future opportunities with AGL or the energy
  industry.

Any applicant that does not submit the required documentation, including documentary evidence, will not be considered for selection.

As part of your application, you will need to agree to the terms and conditions regarding privacy and collection of personal information set out in the Declaration and Authority at the start of your application.

# INFORMATION FOR INDIGENOUS-IDENTIFIED SCHOLARSHIPS

This scholarship is specifically identified for Aboriginal and/or Torres Strait Islander students. To be considered for this scholarship, you'll need to complete a separate process to establish your Aboriginal and/or Torres Strait Islander identity and heritage with the University.

If you have already established your status, you do not need to complete this process again for scholarships (or any other university supports) as the Scholarships Office will already have the necessary information.

If you are new to this process, you can:

- read about the required documents in the <u>Aboriginal and/or Torres Strait Islander Establishing Status</u> within the <u>University Procedure</u>.

We recommend you get this process underway as soon as you know you want to study with the University of Newcastle.

Important: You do not need to upload documents for establishing status within the scholarship portal.

# **SELECTION**

Selection is a competitive process and will be based on assessment of the scholarship application and any required supporting documents, with reference to the eligibility criteria.

Selection will be made by the by the Indigenous Selection Panel which will consist of a minimum of three members chosen by the Pro Vice-Chancellor – Indigenous Strategy and Leadership. The Selection Panel will communicate the details of successful recipients to the Scholarships Office, and all applicants will be notified of an outcome via email within 6 weeks of the application closing date. Where there is only one eligible applicant for a scholarship, the Scholarships Office may award without referral to a selection panel, in consultation with the Office of Alumni and Philanthropy.

#### **CONDITIONS OF AWARD**

If accepting this scholarship, you agree to the following conditions:

- You will continue to meet all relevant criteria in the <u>Eligibility section</u> above for the duration of the scholarship, unless <u>special consideration</u> (see below) is approved.
- If your circumstances change in a way that impacts your eligibility (e.g., change in study load or withdrawal from study), you will notify <a href="mailto:scholarships@newcastle.edu.au">scholarships@newcastle.edu.au</a>.
- The scholarship is tenable for 4 years and must be taken up in the year for which it was awarded, unless
  otherwise specified.
- This scholarship is subject to semester review. Continuation of the scholarship and payment of the scholarship benefit are subject to the scholar maintaining satisfactory academic progress, that is, GPA of 4.0 or higher, and continuing to meet the eligibility criteria of the scholarship.
- Agree to send a thank-you message to the scholarship donor within two weeks of accepting your offer, following the instructions in your scholarship offer letter.
- You will be available to attend a presentation ceremony during Scholars Week (usually around August/September) where you may have opportunity to meet with the donors and/or their representatives.

# **BENEFIT**

The scholarship provides a total benefit of \$20,000, paid as a \$2,500 lump sum in each Semester.

Payments are typically received 2–3 weeks after the semester census date, or 2–3 weeks after you accept your offer if the census date has already passed.

The scholarship benefit and number of scholarships awarded may vary and will be determined by the funding available each year.

#### **PERIODS OF LEAVE**

You may apply in writing to <a href="mailto:scholarships@newcastle.edu.au">scholarships@newcastle.edu.au</a> for consideration to reserve your scholarship if you are unable to study due to illness, injury, or other extenuating circumstances. An application must be supported by documentary evidence.

Periods of approved leave for the scholarship:

- must not exceed two consecutive semesters of study; and
- will not be counted towards the term of the scholarship.

# **TERMINATION**

Unless terminated earlier, the scholarship will end when the term has expired, and the total benefit has been paid.

The Scholarships Office may terminate the scholarship before the term has expired if:

- The scholarship conditions are not met, including relevant eligibility criteria being maintained.
- The scholar completes study and/or ceases to be a student with the University of Newcastle; or
- The scholar has committed serious misconduct (as determined in accordance with the University's relevant policies and rules).

If the scholarship is terminated early, the Office of Alumni and Philanthropy will be advised and the donor notified.

Ongoing scholarships will not be paid out in full in instances where the recipient completes or discontinues study before the full scholarship term has expired.

If you have provided false or misleading information and as a result you were awarded or continued to receive the scholarship, the scholarship may be stopped, and you may be required to repay any scholarship benefits to which you are not entitled to within 14 days of being requested to do so by the University.

#### **SPECIAL CONSIDERATION**

As a scholarship recipient, if you are unable to meet the conditions of the scholarship due to illness, injury or other extenuating circumstances, you may apply for special consideration. Please apply by writing to the Scholarships Office via email to <a href="mailto:scholarships@newcastle.edu.au">scholarships@newcastle.edu.au</a>. Please provide appropriate documentary evidence to support your request.

A decision will be made by Scholarships staff in consultation with the Office of Alumni & Philanthropy.

#### PRIVACY AND COLLECTION OF PERSONAL INFORMATION

If applying for a donor-funded scholarship, the application or a summary of information provided with the application may be provided to an external donor and/or their representative. This is for the purpose of scholarship selection and otherwise to inform the donor that the terms of the donation are met.

You may be asked by Scholarships staff if you give permission for any short articles or newsletter items to be published. You may have the option to provide a photo, quote or short paragraph about yourself for this.

The University of Newcastle is committed to the protection of your personal information and privacy. The University will only disclose your personal information to the extent necessary for the purpose of the provision of this scholarship (including scholarship selection and assessing ongoing eligibility requirements).
