What does this mean for me?

The impact of this change on your progression will depend on which courses you have already completed at the end of 2023 so please ensure you read the following scenarios carefully:

If you have completed both PSYC2600 and PSYC3001 by the end of 2023, these courses will continue to count towards your program. You will not be required to complete either of the new courses.

If you have not completed both PSYC2600 and PSYC3001 by the end of 2023, you will instead complete PSYC2900 and PSYC3006 as core courses in your program. PSYC2900 and PSYC3006 are both scheduled to be offered for the first time in Semester 2 2024. Please ensure that you plan your enrolment accordingly. If you have any concerns about completing these courses in their new term offerings, please contact the Program Advice team via askuon@newcastle.edu.au for advice.

If you have completed ONLY PSYC2600 by the end of 2023, you will need to enrol in PSYC3006 as a core course in your program.

If you have completed ONLY PSYC3001 by the end of 2023, please ensure you enrol in the final offering of PSYC2600 in Semester 2 2024. If you have any questions or concerns about fitting PSYC2600 into your Semester 2 2024 enrolment, please contact the Program Advice team via askuon@newcastle.edu.au for advice. Please note that if you do not successfully complete PSYC2600 in Semester 2 2024, you will need to complete PSYC2900 in addition to a supplementary module from the PSYC3006 course (i.e. the personality component) to ensure you meet accreditation requirements.



Frequently Asked Questions

I have completed PSYC3001, so I need to enrol in PSYC2600 in 2024. What happens if I do not study PSYC2600 as recommended? Will I still be able to complete my program?

Yes, however this will mean that you will need to complete PSYC2900 as well as an additional supplementary module (ie. the personality component) from PSYC3006 in order to meet accreditation requirements. Due to this, it is in your best interest to enrol in PSYC2600 in Semester 2 2024.
