

# TEACHING AND LEARNING COMMITTEE TERMS OF REFERENCE



## Standing Committee of Academic Senate

---

### 1. Establishment

- 1.1 The Committee, originally named the Curriculum, Teaching and Learning Portfolio Committee, was established on 1 January 2002 by the Vice-Chancellor.

### 2. Purpose and Functions

#### 2.1 Purpose

The Teaching and Learning Committee:

- 2.1.1 is the principal advisory committee to Academic Senate for teaching and learning;
- 2.1.2 provides strategic advice to Academic Senate on the quality of teaching and learning:
  - a. to ensure sustained, high academic standards; and
  - b. to support the strategic directions of the University;
- 2.1.3 provides strategic advice to the Senior Deputy Vice Chancellor (Academic) on the implementation of the University Strategic Plan and supporting plans related to teaching and learning;
- 2.1.4 maintains, develops and reviews the implementation of policies on teaching and learning to ensure compliance with the Higher Education Standards; and
- 2.1.5 exercises the responsibilities located in the relevant Rules, Schedules and policies of the University for teaching and learning related matters.

#### 2.2 Functions

The Teaching and Learning Committee will:

- 2.2.1 advise Academic Senate on the development and outcomes of its teaching and learning policies, procedures and practices for enabling, undergraduate and postgraduate coursework programs and courses. This will include:
  - a. pathways that contribute to student access including credit and articulation; participation; retention; and success;
  - b. the admission and selection policies and procedures for undergraduate and coursework degree programs;

- c. program structures and program and course quality to ensure nationally and globally competitive graduates who meet the learning outcomes and priorities of the University;
  - d. methods of assessing the quality of all teaching activities, including those of third party providers;
  - e. work and research integrated learning opportunities;
  - f. innovative approaches to course and program delivery in the University;
  - g. the expansion of leading edge and blended modes of teaching, eg. online delivery and intensive delivery;
  - h. Academic integrity; and
  - i. the sustainability of high quality teaching and learning.
- 2.2.2 ensure regular monitoring and reporting to Academic Senate on the implementation and effectiveness of teaching and learning policies, procedures and practices, using reviews and other methods of evaluation;
- 2.2.3 provide advice to the Programs and Course Approval Committee on the following:
- a. College Response and Action Plans to external program reviews;
  - b. annual program reports;
  - c. innovative options for program delivery;
  - d. policy developments and review; and
  - e. proposals relating to the establishment, revision, discontinuation and disestablishment of coursework programs.
- 2.2.4 provide advice on any other academic policy and quality matters.

### **2.3 Meetings**

- 2.3.1 The Teaching and Learning Committee will meet as frequently as required, but not less than four (4) meetings per calendar year.
- 2.3.2 Standing Orders of the Academic Senate will apply.

## **3. Reporting**

- 3.1** The Teaching and Learning Committee is required to report to Academic Senate in accordance with *Section 2.2 Functions* as listed in this Terms of Reference and any annual cycle of business requirements.
- 3.2** The membership of this committee will be endorsed annually by Academic Senate.

## **4. Membership**

The Teaching and Learning Committee shall consist of the following members:

### **4.1 Ex Officio**

- 4.1.1 Senior Deputy Vice-Chancellor (Academic) (Chair);
- 4.1.2 Deputy President Academic Senate (Teaching and Learning) (Deputy Chair); and
- 4.1.3 President of Academic Senate.

### **4.2 Members**

- 4.2.1 College Associate Dean (Education), or one other senior academic from each College with governance and management expertise in teaching and learning, nominated by the College Pro Vice-Chancellor and appointed by the Chair and the President of Academic Senate;
- 4.2.2 Director of the Pathways and Academic Learning Support Centre, or senior academic of the Centre, nominated by the Director of the Pathways and Academic Learning Support Centre and appointed by the Chair and the President of Academic Senate;
- 4.2.3 Pro Vice-Chancellor (Education Innovation), or nominee;
- 4.2.4 Pro Vice-Chancellor (Student Experience), or nominee;
- 4.2.5 Up to three (3) postgraduate coursework students appointed by the Chair and the President of Academic Senate;
- 4.2.6 Up to three (3) undergraduate coursework students appointed by the Chair and the President of Academic Senate; and
- 4.2.7 Up to five (5) additional members appointed by the Chair and the President of Academic Senate to ensure appropriate expertise in the committee.

### **4.3 Rights of Audience and Debate**

- 4.3.1 Pro Vice-Chancellor (Global Partnerships), or nominee;
- 4.3.2 Pro Vice-Chancellor (Indigenous Strategy and Leadership), or nominee; and
- 4.3.3 Director, Strategy, Planning and Performance, or nominee.
- 4.3.4 In accordance with the Academic Senate Standing Orders, the Chair may grant rights of audience and debate for a specific purpose, meeting or item(s) in a meeting to such a person, persons or categories of person as deemed appropriate.

### **4.4 Terms of Office for Members**

The terms of office for members in categories 4.2.4, 4.2.5 and 4.2.6 will be up to two (2) years from the date of appointment, as determined by the Chair and the President of Academic Senate.

#### **4.5 Quorum**

The quorum for meetings of the Teaching and Learning Committee shall be at least five (5) members and must include the Chair or Deputy Chair, two (2) College representatives and two (2) other members as outlined in 4.2 Members above.

### **5. Subcommittees / Working Groups**

**5.1** The Teaching and Learning Committee may establish sub-committees and/or working parties in respect of specific issues to assist it to meet its obligations.

5.1.1 The Teaching and Learning Committee must establish and approve the Terms of Reference for any other sub-committees or working groups as required to facilitate the work of Teaching and Learning Committee ensuring that the Terms of Reference are consistent with the policies of Academic Senate.

**5.2** Such subcommittees or working groups will make recommendations and report to the Teaching and Learning Committee.

### **6. Authorities (Delegations)**

**6.1** As per the authority vested in this Committee and its Chair by Council, Academic Senate and relevant University policies.

**6.2** On behalf of the Teaching and Learning Committee, the Chair is authorised to recommend urgent business which must be conducted between scheduled meetings of the Committee for approval by either the Academic Senate or by the President of Academic Senate.

**6.3** The Chair will notify the Teaching and Learning Committee of any action taken for recommend items between meetings under urgent business, at the next meeting of the Teaching and Learning Committee.

### **7. Editorial Amendments to Terms of Reference**

**7.1** Editorial amendments as defined in Clause (7.2) may be made to this Terms of Reference following approval by the Chair or the President of Academic Senate.

**7.2** An editorial amendment is an amendment to a title or naming convention, updating hyperlink(s), correcting an inaccurate reference, or rectification of a typographical error. An editorial amendment to a position title is limited to changes where there has been no change to responsibilities.

**7.3** All editorial amendments must be communicated to the next meeting of the Committee or Academic Senate.
