To be eligible to graduate make sure you have completed 80 units (10 units = 1 course unless otherwise specified) which meet the following criteria:

- ✓ LLM without a specialisation - Directed Courses 80 Units. Students may choose any 80 units from the Directed course list to complete the LLM without a specialisation.
- or
- ✓ LLM with one or two specialisations – Directed Courses 80 units. Students must complete a minimum 40 units chosen from one Specialisation Directed Course list to have that specialisation noted on their transcript when the degree is conferred. Students choose the remaining 40 units to complete requirements for a second specialisation, or choose from across program course offerings to finish with a single specialisation.
- ✓ All students who completed their undergraduate Law degree outside of Australia, must complete LAWS6047.
- ✓ International students who completed their Law degree outside Australia and are seeking to meet LPAB requirements to practice Law in Australia should complete the Law in Practice specialisation. Seek advice via the [LPAB international assessment process](#) for LLB and clinical practice to determine which courses you need to choose within the LLM program.
- ✓ The recommended duration of this program is 1 year full time study, or part time equivalent.
- ✓ The maximum time to complete this program is 4 years.
