



HEALTH RESEARCHERS RECOGNISED IN CITY OF NEWCASTLE'S CITIZEN OF THE YEAR AWARD

Two leading University of Newcastle health researchers, Professor Nathan Bartlett and Emeritus Professor Julie Byles have each been honoured in the 2024 City of Newcastle Citizen of the Year Awards.

Assistant Dean Industry and Partnerships at the College of Health Medicine and Wellbeing, Professor Nathan Bartlett, helped develop an effective preventative treatment for respiratory viral diseases including COVID-19, and has been selected as Newcastle's 2024 Citizen of the Year.

Director of the Centre of Women's Health Research, Emeritus Professor Julie Byles, was named Senior Citizen of the Year. She is a long-time advocate for the health of women and older people.




RESEARCHERS HONORED WITH SCIENTIFIC PHOTOGRAPHY PRIZE

The Hunter's best scientific photographers were honoured at HMRI's "Through the Lens" photography exhibition. The University's Dr Jason Girkin took out first prize for his photograph titled 'Nosey Wasowski' depicting a coronavirus replicating in the nasal respiratory epithelium.

Associate Professor Paul Tooney was the runner-up with his photograph titled 'The field of flowers lining the colon', and Ayesha Ali received Highly Commended with a photograph of a highly differentiated rare cell type of intestinal epithelium. 'Through the Lens is a testament to the idea that art and science are not mutually exclusive but rather that they are two sides of the same coin,' says HMRI Director Professor Kay-Lambkin.

SUCCESSFUL RECIPIENTS OF PRESTIGIOUS AUSTRALIA AWARDS FELLOWSHIPS

The 'Master-Reach-Teach: Short Course for Field Epidemiologists' by Dr James Flint and Melinda Phillips, from the School of Medicine and Public Health, was a successful recipient of the highly competitive and prestigious Australia Awards Fellowships.

The University of Newcastle's Field Epidemiology in Action (FEiA) program has been supporting high impact field epidemiology and rapid response team training in the Pacific since 2013.

Co-funded by Hunter New England Health, partnering with Papua New Guinea's National Department of Health, 15 field epidemiology training fellows will come to Newcastle representing all levels of government (local, provincial, and national) to undertake a two-week intensive field epidemiology training program.



PROFESSOR DILEEP SHARMA PRESENTED WITH TWO FELLOWSHIPS FOR WORK IN ORAL HEALTH THERAPY

Professor Dileep Sharma received two fellowships at the FDI World Dental Congress, the Fellowship of Pierre Fauchard Academy and the Fellowship of International College of Dentists. The fellowships recognised Professor Dileep Sharma's contributions and leadership in the field of Clinical Dentistry, Research and Dental education. The FD Congress was attended by 10,000 delegates from all over the world.



NATIONAL MENTAL HEALTH PATHWAYS

Professor Charlotte Rees, Head of the School of Health Sciences, leads the National Mental Health Pathways to Practice Program Pilot as Chief Investigator in collaboration with Monash University. Her leadership has secured \$865,000 in Commonwealth Funds, underscoring her commitment to advancing mental health research and education.



ENGAGEMENT PRIORITIES BETTER HEALTHIER LIVING

ADVANCES IN IMMUNOLOGY AND MICROBIOLOGY

Two Newcastle scientists are among six promising researchers recognised with a prestigious NSW Government grant designed to support and build health and medical research talent in NSW. Dr Emily Hoedt and Dr Guy Cameron have each received a \$500,000 NSW Health Early-Mid Career Researcher Grant.

Dr Guy Cameron, a proud Aboriginal man and immunologist, will establish a genomic technology platform with Dr Trent Butler of NSW Health Pathology for the future control of infectious upper respiratory and ear diseases across our regions.

Microbiologist Dr Emily Hoedt is working to improve colorectal surgical outcomes. Colorectal surgery to remove damaged tissue is the main treatment for many digestive diseases; such as cancer and inflammatory bowel disease.

\$450,000 TO FUND NEW IMAGING EQUIPMENT

University of Newcastle researchers have secured funding from the Australian Research Council for specialist imaging equipment that will reduce the number of animals required in research projects.

The new equipment will be based at the University's BioResearch Building and will complement existing instruments to establish a state-of-the-art imaging facility for animal-based studies - a first of its kind for the Hunter region. The new funding will enable the purchase of a Micro Computed Tomography (microCT) Imaging System that captures high-resolution and high-speed 2D and 3D imaging of the anatomy of living animals in real-time.

The New Colombo Plan (NCP) is an initiative of the Australian Government that aims to strengthen ties between Australia and the Indo-Pacific region by providing opportunities for Australian undergraduates to study and undertake internships in the region.

In 2023, the College supported a record number of students to undertake trips through the NCP. A total of 167 students from 7 disciplines participated in study tours. 18 tours were organised to 6 different countries: Japan, Thailand, China, Philippines, Indonesia, and Fiji.


Using genetically informed precision medicine to improve the treatment of schizophrenia, Prof. Murray Cairns research program will establish a new precision medicine approach that uses a patient's genetic profile to specifically match their disease-associated biology with a broad spectrum of treatments, including existing medications used in psychiatry, as well as those currently used for other conditions.



PROFESSOR PETER GIBSON

Lead by Prof. Peter Gibson, this research program will investigate how different types of treatment can achieve the complete removal of asthma symptoms and attacks, called treatment-induced asthma remission. The cost savings of achieving asthma remission, and consumer views about this new treatment outcome in asthma will be identified.






LIFE READY GRADUATES

HUNTER MEDICAL STUDENTS EARN WHILE THEY LEARN

An Australian-first initiative to boost healthcare staff and provide medical students with invaluable paid experience, is now underway in Hunter New England Local Health District, thanks to a new partnership with the University of Newcastle and TAFE NSW

Minister for Regional Health Ryan Park said the 'Learn while they Earn' pilot program invites first and second year Bachelor of Medical Science/ Doctor of Medicine (Joint Medical Program) students at the University of Newcastle to become Assistants in Nursing through TAFE NSW workshops and clinical placement.
Several wards at John Hunter Hospital, Rankin Park Centre and Belmont Hospital have participated in the pilot program,

with hopes to further expand the program to other facilities across the District during the summer semester break.
