March 2021	 Run a report from the security incident log in relation to reports of physical assault occurring on campus. " a report to be run from the CampusCare database, however the categories will be limited to sexual assault or sexual harassment. Further, descriptors such as 'substantiated and unsubstantiated' don't fit within the victim-led nature of the University's response to these matters, as they are only referred on to the DVC-A for investigation if the victim wishes that to occur.
