

McNair Foundation Indigenous Scholarship

Terms and Conditions

BACKGROUND AND SUMMARY OF KEY CONDITIONS

The intention of this scholarship is to provide financial assistance to an Indigenous student who is studying an undergraduate program at the College of Health, Medicine and Wellbeing or an education program within the School of Education.

If accepting an offer of this scholarship, you will:

- Notify <u>scholarships@newcastle.edu.au</u> of any changes to your circumstances such as reduced study load, change in program, or withdrawal from study which may impact your eligibility for this scholarship.
- Agree to send a thank-you message to the scholarship donor within two weeks of accepting your offer, following the instructions in your scholarship offer letter, and
- Be available for a presentation ceremony during Scholars Week events (usually around September).

The scholarship provides a total maximum benefit of \$30,000 up to a maximum 3-year tenure. The scholarship will be paid as \$10,000 annually, as a \$5,000 lump sum in each semester.

Multi-year scholarships will be paid to recipients for the standard full-time duration of the original degree program, including Honours where applicable.

ESTABLISHMENT

The McNair Foundation Indigenous Scholarship was established by the McNair Charitable Foundation in 2019 to support Indigenous students to complete their undergraduate studies at the University of Newcastle.

FUNDING ARRANGEMENT

This is a donor-funded scholarship from the McNair Foundation.

ELIGIBILITY

To be eligible for this scholarship, you will need to:

- Be enrolled in any year (including Honours) of an undergraduate program offered by the College of Medicine, Health and Wellbeing, OR an Education program within the School of Education at the University of Newcastle;
- Be intending to study on a full-time basis (minimum 60 units per year);
- Have a GPA of 4.0 if you are a continuing student, or the ATAR (or equivalent) required for entry to your program if a new student;

- Not hold another University of Newcastle donor-funded or sponsored scholarship concurrently;
- Establish your Aboriginal and/or Torres Strait Islander status per the process outlined on the Wollotuka Institute's <u>study with us page</u>.

REQUIRED DOCUMENTATION

As part of your application, you will need to prepare:

A personal statement (approx. 1 A4 page) outlining your academic achievements, career aspirations in the
relevant area of study, and how this scholarship would assist you. This statement will cover all scholarships
you are applying for.

Any applicant that does not submit the required documentation, including documentary evidence, will not be considered for selection.

As part of your application, you will need to agree to the terms and conditions regarding privacy and collection of personal information set out in the Declaration and Authority at the start of your application.

INFORMATION FOR INDIGENOUS-IDENTIFIED SCHOLARSHIPS

This scholarship is specifically identified for Aboriginal and/or Torres Strait Islander students. To be considered for this scholarship, you'll need to complete a separate process to establish your Aboriginal and/or Torres Strait Islander identity and heritage with the University.

If you have already done this, you will not need to complete this process again for scholarships or other University supports – scholarships staff will already have the necessary information.

If you are new to this process, you can:

We recommend you get this process underway as soon as you know you want to study with the University of Newcastle.

Important: You do not need to upload documents for establishing status within the scholarship portal.

SELECTION

Selection is a competitive process and will be based on assessment of the scholarship application and any required supporting documents, with reference to the eligibility criteria.

Selection will be made by the Indigenous Selection Panel which will consist of a minimum of three members chosen by the Pro Vice-Chancellor – Indigenous Strategy and Leadership.

The Selection Panel will communicate the details of successful recipients to the Scholarships Office, and all applicants will be notified of an outcome via email within 6 weeks of the scholarship application closing date. Where there is only one eligible applicant for a scholarship, the Scholarships Office may award without referral to a selection panel, in consultation with the Office of Alumni and Philanthropy.

CONDITIONS OF AWARD

If accepting this scholarship, you agree to the following conditions:

- You will continue to meet all relevant criteria in the <u>Eligibility section</u> above for the duration of the scholarship, unless <u>special consideration</u> (see below) is approved.
- If your circumstances change in a way that impacts your eligibility (e.g., change in study load or withdrawal from study), you will notify scholarships@newcastle.edu.au.
- The scholarship is tenable up to a maximum of 3 years and must be taken up in the year for which it was awarded, unless otherwise specified.

- You will remain enrolled in an eligible program for the duration of the scholarship.
- This scholarship is subject to semester review. Continuation of the scholarship and payment of the scholarship benefit are subject to the scholar maintaining satisfactory academic progress, that is, GPA of 4.0 or higher, and continuing to meet the eligibility criteria of the scholarship.
- Agree to send a thank-you message to the scholarship donor within two weeks of accepting your offer, following the instructions in your scholarship offer letter.
- You will be available to attend a presentation ceremony during Scholars Week (usually around August/September) where you may have opportunity to meet with the donors and/or their representatives.

BENEFIT

This scholarship provides a maximum total benefit of \$30,000 paid as \$5,000 each semester for the duration of the scholarship.

Payments are typically received 2–3 weeks after the semester census date, or 2–3 weeks after you accept your offer if the census date has already passed.

The scholarship benefit and number of scholarships awarded may vary and will be determined by the funding available each year.

PERIODS OF LEAVE

You may apply in writing to scholarships@newcastle.edu.au for consideration to reserve your scholarship if you are unable to study due to illness, injury, or other extenuating circumstances. An application must be supported by documentary evidence.

Periods of approved leave for the scholarship:

- must not exceed two consecutive semesters of study; and
- will not be counted towards the term of the scholarship.

TERMINATION

Unless terminated earlier, the scholarship will end when the term has expired, and the total benefit has been paid.

The Scholarships office may terminate the scholarship before the term has expired if:

- The scholarship conditions are not met, including relevant eligibility criteria being maintained.
- The scholar completes study and/or ceases to be a student with the University of Newcastle; or
- The scholar has committed serious misconduct (as determined in accordance with the University's relevant policies and rules).

Ongoing scholarships will not be paid out in full in instances where the recipient completes or discontinues study before the full scholarship term has expired.

If you have provided false or misleading information and as a result you were awarded or continued to receive the scholarship, the scholarship may be stopped, and you may be required to repay any scholarship benefits to which you are not entitled to within 14 days of being requested to do so by the University.

SPECIAL CONSIDERATION

As a scholarship recipient, if you are unable to meet the conditions of the scholarship due to illness, injury or other extenuating circumstances, you may apply for special consideration. Please apply by writing to the Scholarships office via email to scholarships@newcastle.edu.au. Please provide appropriate documentary evidence to support your request.

A decision will be made by Scholarships staff in consultation with the Office of Alumni & Philanthropy.

PRIVACY AND COLLECTION OF PERSONAL INFORMATION

If applying for a donor-funded scholarship, the application or a summary of information provided with the application may be provided to an external donor and/or their representative. This is for the purpose of scholarship selection and otherwise to inform the donor that the terms of the donation are met.

You may be asked by Scholarships staff if you give permission for any short articles or newsletter items to be published. You may have the option to provide a photo, quote or short paragraph about yourself for this.

The University of Newcastle is committed to the protection of your personal information and privacy. The University will only disclose your personal information to the extent necessary for the purpose of the provision of this scholarship (including scholarship selection and assessing ongoing eligibility requirements).

When applying, please review the Declaration and Authority at the start of your application which includes additional information in relation to privacy and the collection of personal information and links to the University of Newcastle Privacy Management Plan, Web Privacy Statement, and UAC Privacy Policy.
