To be eligible to graduate make sure you have completed a total of 400 units (10 units = 1 course unless otherwise specified) which meet the following criteria:

- ✓ Core - 190 units (comprised of 160 units of Laws courses & 30 units of Arts courses).
- ✓ Major - 80 units.
- ✓ Electives - 50 units.
- ✓ Directed Courses - 80 units. Refer to the [Program Handbook](#) for a list of current courses available and up to date information.
- ✓ Students must complete a minimum of 40 units at all levels (1000, 2000, 3000, 4000, and 5000 level), and can complete a maximum of 100 units at 1000 level.
- ✓ The duration of this program is 5 years full time study (40 units per semester).
- ✓ The maximum time to complete is 8 years.
