#### What does this mean for me?

The impact of this change on your progression will depend on which courses you have already completed at the end of 2023 so please ensure you read the following scenarios carefully:

If you have completed both PSYC6826 and PSYC6831 by the end of 2023, these courses will continue to count towards your program. You will not be required to complete either of the new courses.

If you have not completed both PSYC6826 and PSYC6831 by the end of 2023, you will instead complete PSYC6829 and PSYC6836 as core courses in your program. PSYC6829 and PSYC6836 are both scheduled to be offered for the first time in Semester 2 2024. Please ensure that you plan your enrolment accordingly. If you have any concerns about completing these courses in their new term offerings, please contact the Program Advice team via askuon@newcastle.edu.au for advice.

**If you have completed ONLY PSYC6826 by the end of 2023**, you will need to enrol in PSYC6836 as a core course in your program.

If you have completed ONLY PSYC6831 by the end of 2023, please ensure you enrol in the final offering of PSYC6826 in Semester 2 2024. If you have any questions or concerns about fitting PSYC6826 into your Semester 2 2024 enrolment, please contact the Program Advice team via askuon@newcastle.edu.au for advice. Please note that if you do not successfully complete PSYC6826 in Semester 2 2024, you will need to complete PSYC6829 in addition to a supplementary module from the PSYC6836 course (i.e. the personality component) to ensure you meet accreditation requirements.

# **Frequently Asked Questions**

I have completed PSYC6831 only, so I need to enrol in the final offering of PSYC6826 in 2024. What happens if I do not study PSYC6826 in 2024 as recommended? Will I still be able to complete my program?

Yes, however this will mean that you will need to complete PSYC6829 as well as an additional supplementary module (ie. the personality component) from PSYC6836 in order to meet accreditation requirements. Due to this, it is in your best interest to enrol in PSYC6826 in Semester 2 2024.
