Continuing Teaching Staff (Operating Funds)

Continuing Full-time Staff – All NEWSTEP Teachers and ELICOS Teacher Step 3 and above

Continuing Part Time staff – All NEWSTEP Teachers and ELICOS Teacher Step 3 and above where fraction is 0.5 or greater

The requirement to contribute to an approved superannuation scheme, UniSuper Limited is compulsory. A generous employer contribution of 17% of salary is provided. You will be required to make a member contribution at the rate of 7% of salary, however this may be reduced by [Contribution Flexibility](#). Additional voluntary contributions can be made either pre or post tax, please contact the [Superannuation Officer](#) for more information.

Continuing Full time Staff – ELICOS Teacher Steps 1 and 2

Continuing Part time Staff - All NEWSTEP Teachers and ELICOS Teacher Step 3 and above where fraction is greater than 0.2

All NEWSTEP Teachers and ELICOS Teacher Step 3 and above where fraction is between 0.2 and 0.5

The requirement to contribute to UniSuper is not compulsory, however is available as you may elect to join UniSuper Limited as a full member as outlined above.

Should you not wish to become a full member of UniSuper, then Superannuation Guarantee employer payments will be made to UniSuper on your behalf. You are under no obligation to make personal contributions, however voluntary contributions can be made either pre or post tax. Continuing Part time Staff where fraction is 0.2 or less, any NEWSTEP or ELICOS Teacher Step

Fixed Term Teaching Staff (Operating Funds)

All NEWSTEP Teachers and ELICOS Teacher Step 3 and above and period of employment is 2 years or more where fraction is 0.5 or greater

The requirement to contribute to an approved superannuation scheme, UniSuper Limited is compulsory. A generous employer contribution of 17% of salary is provided. You will be required to make a member contribution at the rate of 7% of salary, however this may be reduced by [Contribution Flexibility](#). Additional voluntary contributions can be made either pre or post tax, please contact the [Superannuation Officer](#) for more information.

To become a UniSuper member, you are required to complete the Membership Application form contained in the relevant [Product Disclosure Statement](#).

Period of employment is greater than 1 year and less than 2 years where fraction is greater than 0.2

Period of employment is 2 years or greater where fraction is between 0.2 and 0.5

The requirement to contribute to UniSuper is not compulsory, however is available as you may elect to join UniSuper Limited as a full member as outlined above.

Should you not wish to become a full member of UniSuper, then Superannuation Guarantee employer payments will be made to UniSuper on your behalf. Period of employment is 1 year or less

Fraction is 0.2 or less, any NEWSTEP or ELICOS Teacher Step

Casual Teaching Staff (Operating Funds)

Superannuation Guarantee employer payments to each eligible employee will be made to UniSuper on your behalf. Under The University's [Salary Packaging Policy](#) eligible employees may elect to voluntarily salary sacrifice a fixed percentage of their salary to UniSuper. If you elect to make voluntary contributions please contact the [Superannuation Officer](#) for more information.
