Central Coast Priority List Verification

As part of a joint initiative between the University of Newcastle, the Central Coast Local Health District and State and Federal Government to improve the Central Coast's access to world-class health education, priority will be given to residents of the region when allocating JMP students to commence at the Central Coast Clinical School.

Applicants who indicate they wish to commence studies at the Central Coast Clinical School will be asked to indicate their eligibility for the Central Coast Priority List.

In order to be considered for the Central Coast Priority List an applicant must currently reside on the Central Coast and have done so for no less than two years.

This form cannot be completed by a member of the applicant's family.

Supporting documentation must be received by 1 December 2026. Applications with no supporting documentation or incomplete documentation will not be considered on the Priority List.
