# **Transition Arrangements**

The following description outlines the approved transition arrangements for students who commenced in the Bachelor of Construction Management (Building) (Honours) program prior to 2024. Students who commence the program in 2024 onwards should follow the program structure that is outlined in the Program Handbook.

Built Environment Research Project First offered Semester 2 2024

#### What does this mean for me?

If you have completed both ARBE4121A and ARBE4121B by the end of 2023, your program requirements will remain unchanged. ARBE4121A and ARBE4121B will continue to count as core courses in your program. You will not be permitted to study ARBE3121 or ARBE4121.

If you have not completed both ARBE4121A and ARBE4121B by the end of 2023, you will need to study new core courses, ARBE3121 and ARBE4121, in place of these two courses.

### **Frequently Asked Questions**

On the program handbook, ARBE1106 has been added as a core course. If I started prior to 2024, do I need to complete ARBE1106?

No. Students who commenced the program prior to 2024 should follow the program structure outlined in their Program Planner. This will involve continuing to study 40 units of electives. ARBE1106 can be completed as an elective if you are interested in taking the course.

I met the requirements of ARBE4121A in Semester 1 2023 but did not successfully complete ARBE4121B. Do I need to enrol in both ARBE3121 and ARBE4121?

Yes. As ARBE4121A & ARBE4121B were multi-term sequences courses, if you were unsuccessful in completing ARBE4121B, you must enrol into <u>both</u> ARBE3121 and ARBE4121 in future terms.
