



# Joblink Plus Disability Scholarship Conditions

## BACKGROUND AND SUMMARY OF KEY CONDITIONS

The intention of this scholarship is to provide financial assistance to a student with a disability who is currently enrolled in a program at the University of Newcastle

If accepting an offer of this scholarship, you will:

- Notify [scholarships@newcastle.edu.au](mailto:scholarships@newcastle.edu.au) of any changes to your circumstances - such as reduced study load, change in program, or withdrawal from study – which may impact your eligibility for this scholarship.
- Agree to send a thank-you message to the scholarship donor within two weeks of accepting your offer, following the instructions in your scholarship offer letter, and
- Be available for a presentation ceremony during Scholars Week events (usually around September).

The total value of this scholarship is \$8,000 for a term of one year.

## ESTABLISHMENT

Joblink Plus is a for-purpose, not-for-profit organisation providing employment services and vocational training. We deliver to a range of communities across rural and regional NSW, covering around 70% of the state. Joblink Plus places approximately 11,000 people into employment annually. We support communities through direct contributions, social enterprise, and volunteering. We partner with a diverse range of organisations with shared values, including health initiatives as well as various youth and Indigenous programs. Our purpose is to believe in and provide support to all people, connecting them to the dignity and fulfilment made possible through education and meaningful work.

In collaboration with the University of Newcastle's Pathways and Academic Learning Support Centre, Joblink Plus has established this scholarship to support and facilitate inclusive, broad and equitable access to university for people who may not otherwise have a connection to tertiary education.

## FUNDING ARRANGEMENT

This is a donor-funded scholarship from Joblink Plus.

## ELIGIBILITY

To be eligible to apply for this scholarship, you will need to:

- Be an Australian citizen or permanent resident
- Be enrolled in any year of any program at the University of Newcastle
- Not hold another donor scholarship or sponsorship concurrently.
- Demonstrate that your ability to study is affected, or will be affected, by the area of educational disadvantage: Long term medical condition/disability or ongoing effects of abuse\*

\*Long-term medical condition/disability or ongoing effects of abuse definition

A person whose ability to study at university is being affected, or is likely to be affected, by the long-term and ongoing effects of one of the following:

- a severe and long-term (or a severe and recurrent) medical/psychiatric condition or illness
- a learning, sensory, physical, psychological or other disability/disorder
- trauma or abuse

As part of your application, you will need to prepare:

- A personal statement (no more than 1 A4 page) outlining your academic achievements, career aspirations in the relevant area of study, and how this scholarship would assist you. This statement will cover **all** scholarships you are applying for.
- You *may* be required to provide documents to support your educational disadvantage claims. These will be identified when you apply based on your individual application responses, but you can get an idea of what kinds of documents are required [here](#).

Any applicant that does not submit the required documentation, including documentary evidence, will not be considered for selection.

As part of your application, you will need to agree to the terms and conditions regarding privacy and collection of personal information set out in the Declaration and Authority at the start of your application.

## SELECTION

Selection is a competitive process and will be based on assessment of the scholarship application and any required supporting documents, with reference to the eligibility criteria.

Selection will be made by the Multi College Selection Panel which will consist of a minimum of three members chosen by the Senior Deputy Vice-Chancellor – Academic Division.

The Selection Panel will communicate the details of successful recipients to the delegated Scholarships Officer, and all applicants will be notified of an outcome via email. Where there is only one eligible applicant for a scholarship, the Scholarships Officer may award without referral to a selection panel, in consultation with the Office of Alumni and Philanthropy.

## CONDITIONS OF AWARD

If you accept this scholarship, you agree to the following conditions:

- You will continue to meet relevant eligibility criteria (see the section titled “Eligibility” above) for the duration of the scholarship, unless special consideration is approved (see below).
- If your circumstances change in a way that impacts your eligibility (e.g., change in study load or withdrawal from study), you agree to notify [scholarships@newcastle.edu.au](mailto:scholarships@newcastle.edu.au).
- Agree to send a thank-you message to the scholarship donor within two weeks of accepting your offer, following the instructions in your scholarship offer letter.
- You will be available to attend a presentation ceremony during Scholars Week (usually around August/September) where you may have opportunity to meet with the donors and/or their representatives.

## BENEFIT

This scholarship must be taken up in the year for which it is awarded.

The scholarship provides a total benefit of \$8,000 up to a maximum 1-year tenure provided ongoing eligibility for the term of the scholarship.

The scholarship will be paid as a \$4,000 lump sum each semester after the relevant census dates.

The scholarship benefit and number of scholarships awarded may vary and will be determined by the funding available each year.

## PERIODS OF LEAVE

You may apply in writing to [scholarships@newcastle.edu.au](mailto:scholarships@newcastle.edu.au) for consideration to reserve your scholarship if you are unable to study due to illness, injury, or other extenuating circumstances. An application must be supported by documentary evidence.

Periods of approved leave for the scholarship:

- must not exceed two consecutive semesters of study; and
- will not be counted towards the term of the scholarship.

## TERMINATION

Unless terminated earlier, the scholarship will end when the term has expired and the total benefit has been paid.

The Scholarships office may terminate the scholarship before the term has expired if:

- The scholarship conditions are not met, including relevant eligibility criteria being maintained;
- The scholar completes study and/or ceases to be a student with the University of Newcastle; or
- The scholar has committed serious misconduct (as determined in accordance with the University's relevant policies and rules).

If the scholarship is terminated early, the Office of Alumni and Philanthropy will be advised and the donor or sponsor notified.

Ongoing scholarships will not be paid out in full in instances where the recipient completes study before the full scholarship term has expired.

If you have provided false or misleading information and as a result you were awarded or continued to receive scholarship payments, the scholarship may be stopped, and you may be required to repay any scholarship benefits to which you are not entitled within 14 days of being requested to do so by the University.

## SPECIAL CONSIDERATION

As a scholarship recipient, if you are unable to meet the conditions of the scholarship due to illness, injury or other extenuating circumstances, you may apply for special consideration. Please apply by writing to the Scholarships Officer via email to [scholarships@newcastle.edu.au](mailto:scholarships@newcastle.edu.au). Please provide appropriate documentary evidence to support your request.

A decision will be made by Student Central Scholarships staff in consultation with the Office of Alumni and Philanthropy.

## PRIVACY AND COLLECTION OF PERSONAL INFORMATION

If applying for a donor-funded scholarship, the application or a summary of information provided with the application may be provided to an external donor and/or their representative. This is for the purpose of scholarship selection and otherwise to inform the donor that the terms of the donation are met.

You may be asked by the Scholarships Officer if you give permission for any short articles or newsletter items to be published. You may have the option to provide a photo, quote and/or a short paragraph about yourself for this.

The University of Newcastle is committed to the protection of your personal information and privacy. The University will only disclose your personal information to the extent necessary for the purpose of the provision of this scholarship (including scholarship selection and assessing ongoing eligibility requirements).
