# **OVERVIEW**

**Course Description** 

This course offers advanced training in fiction writing for students aiming to write their first novel. Through a study of exemplars in different genres and the development of their own work and ideas, students will explore the narrative options available in the writing of a novel. They will learn how to edit, redraft and shape a larger work both collaboratively and independently.

# **SYLLABUS**

**Course Content** 

This course lays the foundation for the development of a novel. Students will study larger issues like genre, reading audience, theme, structure, voice and style, besides working on basic features such as scene, plot and character. They will learn to shape their work through drafts and redrafts in collaborative workshops and through consultation with the lecturer.

#### Course Learning Outcomes

### On successful completion of this course, students will be able to:

- 1. Describe and analyse the technical decisions made by novelists writing in different genres.
- 2. Use a range of writing techniques common to prose fiction.
- 3. Edit and refine written language in terms of grammar and sentence construction.
- 4. Identify through independent research and class discussion, issues relating to the writing of novels such as genre, target audience and writing process.
- 5. Develop scenes and opening chapters that reflect the technical features of novelistic writing.

**Description** Write a single scene featuring a dramatic high point—that is, a significant change in some

story value—that reflects one of the major themes with which your novel is concerned. This scene may be from any part of the book, except the opening chapter, as this will be covered by a different assignment! The scene must have a beginning and end. It must feature a dramatic high point, a clear sense of place, and an engaging conflict. Other features of writing that will be assessed in this assignment include: language, characterisation, imagery, and perspective. Please consult the rubric related to this assignment for further information—It summarises everything you need to know to turn an idea into a scene from a novel.

## Assessment 2 - Long Creative Assignment (50%)

Assessment Type Professional Task

**Purpose** Writing the first chapter or section of your novel

**Description** Write the first chapter or section of your book. Your first chapter/section should establish a

clear sense of the perspective, voice, and narrative mode you will be using, and include a conflict that evokes the themes with which your book is concerned. It should also effectively orient the reader in the time and initial setting of your novel. Please consult the rubric related

to this assignment for further information.

## Assessment 3 - Query letter (15%)

Assessment Type Professional Task

Purpose Writing a query letter to a publisher or editor

**Description** Write a query letter (450—500 words) addressed to an agent or publisher. Include a brief note

(100 words) separate to the query but submitted as part of the assignment, indicating why you chose this agent and whether they had any specific requirements. This is a simulated WIL exercise, so you will not need to send this letter/email—a real query is usually sent after a solid draft of a novel has been written. In this query exercise, however, you will present and sell your novel as if it has been written. This will no doubt require you to come up with some plot details that you have not yet settled upon. The rubric for this assignment—as well as the

course notes—will provide more information on how to complete this assignment.
