## **OVERVIEW**

Course Description	This 24-day placement will give students practical skills in professional clinical psychology practice. Students will have opportunities to develop inter-personal, intra-personal and professional/clinical skills; to observe practice by qualified professionals; to apply, under supervision, the knowledge, and skills they have acquired in assessment, formulation, intervention, evaluation and reporting; to receive feedback on their performance; and to gain experience in the planning and organisation of services. At the conclusion of this placement, students will demonstrate foundational skills in clinical psychology practice relevant to the context.

- 2. Observation of the supervisors' professional work, including (where relevant) reports of clinical activity.
- 3. Attendance at and participation in supervision meetings.

- 5. Instruction and guidance in ethical and professional conduct, the choice of assessment instruments, the development and evaluation of psychological formulations and action plans, and the construction of reports.
- 6. Feedback on and supervision of the student's placement work.

	limit will not be included within the allocation of marks. In other words, the marker will STOP reading at 1925 words.
