## OVERVIEW

<b>Course Description</b>	Through this course criminal justice students will engage directly with organisations that require criminological input into their policy, evaluation, and professional practices. Under supervision, students will undertake an external or internal 140-180 hour work placement with appropriate organisations involved in criminal justice research, education, or community engagement. This direct experience will expose students to the discourses and practices of researchers and managers, in order to consider the many complex factors that influence criminological research and policy. The importance of understanding cultural diversity of offenders and victims, as well as strategies to support their human rights in the criminal justice system (CJS), will also be highlighted.
<b>Requisites</b>	To enrol in this course you must have successfully completed CRIM2001.
<b>Assumed Knowledge</b>	40 units of CRIM-coded courses
<b>Contact Hours</b>	<b>Callaghan Practicum</b> Face-to-face on and/or off campus 80-hour (CRIM3001) placement on or off campus 140-180 (CRIM 3002) placement on or off campus  <b>Seminar</b> Face-to-face on campus 2 hours – week one (required)
<b>Unit Weighting Workload</b>	20 Students are required to spend on average 120-140 hours of effort (contact and non-contact) including assessments per 10 unit course.
<b>Skills Focus</b>	This course will focus on assisting students to develop the following skills: <ul style="list-style-type: none"><li>• Assess and use resources</li><li>• Structural and writing skills</li><li>• Self-reflection and resilience</li><li>• Oral communication skills</li></ul>

# SYLLABUS

## Course Content

The course will provide students the opportunity to develop a vocational understanding of the criminal justice system (CJS) through a work placement. Vocational places will be sourced from across the CJS, including those within (but not limited to) organisations focused on criminal justice policy, research, and practice. Placements with a specific focus on Indigenous content will be encouraged.

Activities undertaken will provide students with the skills necessary to describe and critically reflect on a major placement, and discuss the role of criminal justice in policy, practice, management, and research.

Students will:

- Apply for (with the assistance of Academic and Professional Staff), secure, and complete a vocational placement
- Engage with professionals working within the CJS
- Collaborate to plan, carry out, and report on an appropriate needs assessment, research project, or evaluation.
- Complete an 80-hour (CRIM 3001) or 140-180 hour (CRIM 3002) placement with an organisation that requires criminal justice expertise
- Record, report and critically reflect on placement experiences
- Discuss aspects of criminal justice practice with peers and commissioning agencies
- Describe and analyse issues relating to real world research and practice in criminal justice

Note: To pass the course, all assignments, forms required by the host organization, and (if relevant) non-disclosure forms must be completed. Additionally, a log of placement hours **must** be uploaded into Sonia.

## Course Learning Outcomes

**On successful completion of this course, students will be able to:**

1. Apply advanced criminal justice skills relevant to working with a range of criminal justice stakeholders in a vocational setting.
2. Evaluate outcomes for offenders and victims in a vocational setting, demonstrating expertise.
3. Construct a report relating to working with offenders or victims of crime.
4. Show advanced professional knowledge through the undertaking of case-based tasks related to working with offenders and victims of crime in a vocational setting.
5. Critique issues facing criminal justice professionals in the workplace.
6. Employ professional knowledge gained within your own professional practice.

**Course Materials** Course materials are dependent on and may be supplied by the host organisation. Additional course materials specific to the University of Newcastle will be posted to the Canvas site for this course and advised to students via course announcements.

**Compulsory Requirements** There is a compulsory attendance requirement in this course. Attendance at all classes (seminars and workshops as well as placement hours with your “host”) will be monitored and records maintained by the Course Coordinator. In order to satisfy the “Attendance” requirement, students must be present at a minimum of 80% of scheduled university classes and complete the minimum of 80 hours with the placement host as spelled out in the course outline, unless they are able to demonstrate that their absence falls within the Adverse Circumstances policy. Unless this requirement is met, despite marks awarded in other assessment items, the student will receive a zero mark and an CF grade for the course.

You must upload your hours sheet into the Sonia platform to successfully complete the course.

**Please note** that if you miss more than 2 classes for reasons that fall within the University’s adverse circumstances policy you may be required to complete additional assessment items to ensure that you have completed the required volume of learning for this course.

## ASSESSMENTS

This course has 3 assessments. Each assessment is described in more detail in the sections below. Along with the required hours for the placement, these assignments must be completed to pass the course. They are graded as Pass/Fail thus it is very important to meet the requirements of each assignment.

**Late Submissions** The mark for an assessment item submitted after the designated time on the due date, without an approved extension of time, will be reduced by 10% of the possible maximum mark for that assessment item for each day or part day that the assessment item is late. ### Assessment 1 - Written Assignment (25%)

**Assessment Type Description** Written Assignment/Ethical Considerations  
The purpose is to ensure you understand the structure of your host institution, specific expectations of professional engagement, as well as the importance of working ethically within it.

**Weighting** 25%

**Length** 1,000 words (+/- 10%)

**Due Date** 5pm Friday, first week of student’s placement (this will vary based on your placement)

**Submission Method** Online

**Assessment Criteria** Ungraded Pass or Fail. Provided via a rubric in the Assessment section of Canvas

**Return Method** Online

**Feedback Provided** Individual feedback, three working weeks post-submission. Online, via TurnItIn.

### Assessment 2 - Report (50%)

**Assessment Type Description** Professional Task  
This assessment task involves the completion of a project/report as directed by your host organisation. In the early stages of your placement program you are to agree with your host organisation a project for you to complete. This assessment task will that specific project or a reflection of that task. Examples of previous projects; learning to take case-notes, creating an

infographic regarding a recent policy change, plan events for Reconciliation Week, complete a risk assessment, compile a list of resources for the homeless in Newcastle, and writing movie reviews for a magazine.

Recognising that each placement will be different, and that each student may be required to complete different tasks, you are advised to contact your course co-ordinator or teaching staff to agree on the terms, structure, and style of this assessment task. If your supervisor does not have a specific task for you, please reach out to the course coordinator.

<b>Length</b>	Min 1,000 words
<b>Due Date</b>	5pm Friday, week 13
<b>Submission Method</b>	Online
<b>Assessment Criteria</b>	Ungraded Pass or Fail. Provided via a rubric in the Assessment section of Canvas
<b>Return Method</b>	Online
<b>Feedback Provided</b>	Overall feedback on the cohort's projects will be provided to via canvas three weeks post submission.

### Assessment 3 - Reflective journal (25%)

<b>Assessment Type</b>	Journal
<b>Description</b>	This assessment task will be a theoretically-informed reflection on the journey during the placement, with a particular focus on criminological theory and practice. Drawing upon the theories you have encountered in your study of criminology, you are to apply them to the experiences during your criminal justice placement. A reflective journal encourages you to stand back and think about what you have learnt across your educational journey and during your placement. It encourages you to think about how ideas and practices fit together or diverge, and how previous assumptions may have been reinforced or challenged. Importantly, a reflective journal is not a personal diary, and we do not want to see a list or log of what you have done each day. It is a theoretically informed account of your experience engaging in theory and practice. As such, a reflective journal is a scholarly document. However, I do not expect a high degree of referencing, though it should be very clear which theories you are using to analyse your experiences/cases.

There are two submission options for this assessment and you can select ONE of the two. The first is a written document submitted via Turnitin in Canvas. The second is a 7-8 minute verbal presentation that can be recorded and uploaded onto Canvas. The recording must include either your face, powerpoints, or some other visual component to complement the presentation.

<b>Return Method</b>	Online
<b>Feedback Provided</b>	Final assignment will not receive feedback, please email for individual feedback. Online, via Turnitin.

<b>Assessment Moderation</b>	To ensure that grades are fair both within and between courses and cohorts, Newcastle Law School has a rigorous policy of moderating and reviewing assessment. The School Assessment Board (SAB) reviews all final grades before they are released to students, and the SAB process may result in the overall marks of a class being moved up or down by a specific amount, thus impacting individual marks.
