By taking narratives of medicine and psychology as the focus, this course enables a close consideration of strategies for representing the body, the mind, pain, and healing in fiction. The course contributes to students' future career potential whether as creative or other kinds of professional writers – and provides them with a better understanding of how literary works are constructed. Students will develop a narrative-based understanding of experiences of illness and healing. Using the workshop model of creative writing, students will develop the tools to write creatively about traumatic or difficult topics in a sensitive and engaging way. Topics will be explored theoretically and with the aid of exemplars, but the main focus of both class work and independent study will be the practical application of creative and aesthetic principles.
