OVERVIEW

Course Description Social development aims to help individuals, communities and societies live well and achieve their potential. It is strongly interconnected with environments and places; with legacies of the past and designs for the future. This course is the first in a sequence (followed by ENVS2008, then ENVS3006) that covers the social and cultural dimensions of environmental change from pre-colonial times through to the present. Through Australian and international case studies, skill development activities and research, you will explore different cultural perspectives and examine relationships between development and social, environmental, and economic justice. You will also study issues central to improving our world today, including climate change, biosecurity and urbanisation.

Course Content The course enables students to develop introductory skills in research and effective communication. A range of socio-environmental issues, perspectives and contexts are examined. The course also explores environmental history, current challenges and opportunities to create better futures.

2. Analyse the relationship between social development and environments in a range of contexts
3. Understand the role of culture in the production and management of environmental issues
4. Demonstrate effective communication of environmental and social development concepts and issues.
