OVERVIEW

Course Description

Thesis Preparation forms part of the Honours Program for Geoscience. This course provides students an opportunity to advance the skills and knowledge they acquired throughout their undergraduate studies through thesis formulation. It covers advanced topics in research methodologies and ethics relevant to the projects undertaken by the cohort of students at this level.

This course is part of the multi-sequence research component of honours which requires the development of original research under the supervision of a member of academic staff from the School of Environmental and Life Sciences. In Part A, students will undertake preparation work for their thesis, completing this final body of work in Part B.
