OVERVIEW

Course Description	Legal System and Method is the second foundational course in the Juris Doctor. Students continue to develop core intellectual and analytical skills in the discipline of law, with a particular focus on statutory interpretation. The course also introduces students to the nature and operation of the Australian Constitutional framework. In addition, the course continues the process of professional legal education, focusing especially on oral communication with legal audiences and self-management skills for professional practice.
Requisites	This course is only available to students enrolled in the Juris Doctor/Graduate Diploma in Legal Practice (12334) or Bachelor of Teaching (Humanities) (Honours) (12368) or Bachelor Education (Secondary) (40107) or Bachelor of Education (Secondary) (Honours) (40108) programs.

Description	The moot appearance introduces students to appellate advocacy and the requirements of court etiquette. Students work in pairs to prepare legal submissions and present an oral argument in response to a moot problem.

Assessment 3 - Final Exam: Legal system –Problem Solving in Statutory Interpretation and Constitutional Law

Assessment Type	Formal, open–book exam
Description	Notes and books (other than University library books) may be used. The exam will require application of the principles taught in the course to fact situations and provide a critical commentary on aspects of the Australian Constitution. Students are, of course, responsible for arranging to be available for the allocated examination dates when they are published according to University procedures.

Submission Method	Formal
Assessment Criteria	<p>Constitutional Framework in exam: In providing a critical commentary, students give attention to the identification of contexts in the extract, analysis of its content, and an assessment of its significance for the constitutional framework. Students apply critical thinking skills to write a commentary on selected extracts of primary data drawn from legal materials. Each student employs the correct legal language and terminology, reads and analyses case law effectively to structure and present a coherent and persuasive written argument incorporating the supplied legal data.</p> <p>Statute Problem Solving Exercise in exam: This exercise assesses by means of problem questions the student's statutory knowledge and interpretation. Using lateral thinking, students apply relevant statutory provisions and regulations to solve legal problems through the range of available dispute resolution mechanisms. Students use this specialised knowledge of law and its application to demonstrate their capacity to provide professional advice to a range of audiences.</p>

Assessment 4 – Compulsory Attendance at Seminars and Workshops

Assessment Type	Attendance at seminars and workshops
Description	Attendance and active participation requirement
Weighting	Irrespective of a student's mark, if a student has achieved overall marks greater than 50% in a course but has failed to satisfactorily complete a compulsory course requirement then a zero mark and fail grade (FF) will be recorded on their transcript.
Submission Method	Presence
Assessment Criteria	<p>Attendance at all classes (seminars and workshops) will be monitored by the keeping of a roll, usually in the form of a sign-in sheet or roll call; the roll will be recorded. To satisfy this requirement, students must be present at a minimum of 80% of scheduled classes as spelled out in the course outline, unless they are able to demonstrate that their absence falls within the Adverse Circumstances policy. Unless this requirement is met, despite marks awarded in other assessment items, the student will receive a zero mark and an FF grade for the course. Please note that if you miss more than 2 classes for reasons that fall within the University's adverse circumstances policy you may be required to complete additional assessment items to ensure that you have completed the required volume of learning for this course.</p> <p>Please note that meeting the attendance rule each week requires meaningful attendance for the full one hour and fifty minutes of each class. Partial attendance will not meet the attendance requirement for a given class unless prior approval has been given by the Course Coordinator or Lecturer. (To be clear, simply being present for purposes of the roll call does not on its own satisfy the attendance requirement.
