#### **Course Content**

A descriptive analysis of the structure of contemporary English. Topics covered will be selected from the following:

- formal criteria for word class identification
- properties of phrasal structure
- analysis of simple clause structures
- major grammatical categories of the verb: tense, aspect, voice
- · grammatical relations
- finite and non-finite subordinate clauses
- interrogative structures

- 2. Explain key grammatical concepts, such as syntactic constituent and embedding of syntactic structure.

- 5. Apply your knowledge of the research process to contribute to a research project
