Course Description	Keeping the woman firmly in the centre, this course analyses evidence which underpins best care for women and their unborn/newborn babies when they meet challenges during the first, second and/or third stage of labour. Complex labour may bring with it the possibility of unwanted, unexpected, and/or difficult processes, tests, interventions, and/or outcomes that can affect short and long term maternal and fetal/neonatal wellbeing. Critically analysing midwifery, medical, neurophysiological, pharmacological, and sociological theory, postgraduate students examine causes and possible outcomes of complex labour and/or birth for both women and their babies, further understand the provision of safe midwifery care, and care from the multidisciplinary team, and reflect on and examine necessary professional relationships and respectful partnerships.	<b>OURS</b>

### Assessment 2 - Quality Improvement Report/Poster Presentation

Assessment Type Exhibition / Poster

- Purpose This assignment challenges you to advocate for enhanced maternal care. By selecting a welljustified practice, substantiating your arguments with solid evidence, and addressing potential challenges, you will craft a compelling case for implementing change. Keep in mind that the ultimate goal is to gain the support of senior leadership in implementing this change for the betterment of women experiencing complex labour and birth.
- **Description** In this assignment, you have the opportunity to select a practice aimed at elevating the care provided to women undergoing complex labour and/or birth. Your task is to craft a comprehensive report that justifies the adoption of a chosen practice, incorporating detailed analysis, critical evaluation, and evidence-based recommendations. This report aims to gain approval from senior management for implementing the change, focusing on improving maternal and baby well-being while adhering to various healthcare frameworks and addressing workplace constraints. You may present this in written form or as a poster.

Your report must provide:

- Analysis of Physiological Causes and Outcomes: Provide an in-depth analysis of the physiological causes behind the chosen complexity in both women and their babies during labour and/or birth. Explore the possible outcomes that can arise due to these complexities, considering the potential impact on maternal and fetal health.
- **Critical Evaluation of Change's Health Promotion and Harm Prevention:** Critically evaluate how the chosen change promotes health and prevents harm for women and their babies in complex labour and/or birth situations. Scrutinise the effectiveness of the proposed practice in enhancing positive outcomes and minimising potential risks.
- Compelling Evidence and Risk Acknowledgment from Peer-Reviewed Sources (APA 7th Referencing): Support your recommendations with compelling evidence from peer-reviewed sources, adhering to APA 7th referencing guidelines. Ensure that the sources are reputable and scholarly in nature. Additionally, acknowledge any potential risks associated with the proposed change, providing a balanced viewpoint.
- Evaluation of Supporting Women's Choices: Evaluate how the proposed change aligns with and supports women's choices during complex labour situations. Discuss how the practice empowers women to make informed decisions regarding their care while promoting positive outcomes.
- Integration of Legal, Ethical, Professional, Pharmacological, and Policy Frameworks: Demonstrate how the proposed change aligns with legal, ethical, professional, pharmacological, and policy frameworks or protocols relevant to midwifery practices during labour and/or birth. Explain how the change adheres to these guidelines while enhancing maternal care.
