OVERVIEW

Course Description

This course provides students with the opportunity to further develop professional knowledge, experience and competence, in conventional and conformal low to medium level clinical procedures, by participating in professional skill labs at University and by attending a professional placement at an accredited radiation therapy clinical centre. The labs must be passed to be allowed to attend professional placement, and pass the course. This course is mandatory and must be passed in order to progress in the Bachelor of Medical Radiation Science (Radiation Therapy) Bachelor of Medical Radiation Science (Honours) (Radiation Therapy).

This Course recognises the Professional Capabilities developed by the Medical Radiation Practice Board of Australia. The Document 'Professional Capabilities For Medical Radiation Practice' outlines via Domains the requirements for a Competent Practitioner. Domain 1: Medical Radiation Practitioner 1C: Radiation Therapist Domain 2: Professional and ethical practitioner Domain 3: Communicator and collaborator

SYLLABUS

Course Content

- 1. Isocentric Treatment & Planning
- 2. Conventional and Conformal Radiation Therapy approaches
- 3. ICRU Report 50 and Report 62 Prescribing, Reporting and Recording External Beam Therapy
- 4. Dosing techniques and plan evaluation including visual assessment, statistical assessment, dose-volume histogram assessment, biological models of dosing
- 5. 3-dimensional planning
- 6. Patient assessment with regard to quality of life, living with illness, and treatment toxicity criteria

Course Learning Outcomes

On successful completion of this course, students will be able to:

1. Demonstrate competence in the design and quality assurance checking of basic and medium-level treatment plans and implementation of plans into treatment.

2. Evaluate plans against ICRU criteria and ensure that they meet recognised and accepted criteria (ICRU 50/62)

3. Participate in basic and medium-level radiation therapy treatment, planning and simulation procedures.

4. Demonstrate a professional attitude towards members of the public and other healthcare workers.

5. Apply effective communication to members of the public and other healthcare workers, such as information gathering, active listening and empathy.

6. Practice within an ethical and legal framework.

7. Develop clinical reasoning/management skills.

8. Apply the skills and knowledge necessary to employ an evidence-based approach to decision making in healthcare practice.

9. Reflect upon, and evaluate and critique his or her role within and during the clinical period, according to the level of experience.



COMPULSORY REQUIREMENTS

In order to pass this course, each student must complete ALL of the following compulsory requirements:

Contact Hour Requirements:

Professional Placement: There is a compulsory attendance requirement in this course. Minimum of 210hours/30 shifts of compulsory clinical practice during the semester.

NOTE: Placement is a mandatory component of your degree. You will not graduate if you cannot satisfactorily complete placement. You will not be able to enter a NSW Health facility unless you have completed the pre-placement requirements.

Seminar There is a compulsory attendance requirement in this course. Clinical Briefing 2 hrs per semester compulsory attendance.

Course Assessment Requirements:

- Assessment 1 Tutorial / Laboratory Exercises: Pass Requirement Students must pass this assessment item to pass the course. Labs are a compulsory course requirement with 100% attendance required
- Assessment 2 Portfolio: Pass Requirement Students must pass this assessment item to pass the course.

In order to pass the course, students must obtain the following grades in the Final Summative Assessment - A minimum of '3' (Satisfactory level of achievement) in Sections 1-4

- A minimum "S" (Satisfactory level of achievement) in Sections 5 and 6

Compulsory Placement and WHS Requirements:

- NSW Health Verification Requirements Mandatory NSW Health Verification Requirements must be met. Current first aid certificate
- NPC National Police Check
- International Students (additional requirements): Police Certificates from all previous countries of residence
- Students will be allocated a clinical placement. Students cannot change their clinical placement site due to not being able to demonstrate the above requirements. Any student excluded from placement because they are unable to demonstrate the above requirements will not be able to pass this course and will be given a failed grade (FF) for the course. Any student not able to fulfil the above requirements or who is unwilling to meet these requirements needs to make an appointment with the course coordinator to discuss their progress in this course and the degree.

This course has block placements. The final date that a student may withdraw without penalty from this course is 1 week prior to the commencement of placement.

Assessment 2 - Professional Skills / Clinical Competence Portfolio

Assessment Type Description	Portfolio Professional Placement Workbook:
	1. Professional Skill Attainment: The Radiation Therapy program has a list of competencies (Professional skills) that all students of the program should be able to attain. Students have 6 weeks of Professional Placement and during this time should be able demonstrate Professional Skill attainment. Where students have not attained the required skills during the placement, the Clinical Supervisor of the Placement will be contacted to advise of the reasons (e.g., lack of procedures or opportunity during the placement, or lack of skill by the student). Where the Clinical Supervisor indicates that the opportunity was available for the student to gain the necessary skill, those students not able to demonstrate the attainment of the required skills will be assessed as Unsatisfactory for the assessment item, and will not meet the essential criteria requirements for the assessment item, and will be given a fail grade (FF) for the course.
	2. Radiation Therapy Clinical Supervisors assessment: This report assesses the student against a series of skill-based and attitudinal indicators undertaken on their rotation through-out the department. The assessment report contains both weekly formative feedback, and a final summative assessment. Students failing to meet the essential criteria will not meet the essential criteria requirements for the assessment item and will be given a failed grade (FF) for the course. The student must attain a 50% mark in this section to pass the course. The Clinical Supervisor Report is weighted as 40% of the course mark.
	<i>3. Radiation Therapy Critical analysis and reflection on practice reports:</i> Students are required to obtain a combined mark of 50% in this section for critical analysis and reflection reports. The combined mark of the Critical analysis and Reflection on practice reports is weighted as 40% of the course mark.
Weighting Compulsory Requirements	 4. Professional Placement Hours or Shifts: Students are expected to meet the attendance requirements for Professional Placement. Students not meeting the attendance requirements for Professional Placement will not meet the essential criteria requirements for the assessment item and will be given a failed grade (FF) for the course. No opportunity for remediation for the Professional Placement will be allowed unless accompanied by the appropriate Adverse Consideration documentation. 80% (Supervisor Report=50%, Written Report A= 15%, Written Report B=15%) Pass requirement - Must pass this assessment item to pass the course.
