NURS3002: Essentials of Palliative Care

OVERVIEW

Course Description

The course will enable students to develop principles of person centred, evidence-based nursing care for people with a life limiting illness across the lifespan and apply the principle of palliative care. The case studies are informed by the National Health Priority Areas. There will be a strong focus on promoting dignity and quality of life for the palliative care person and their family. By the end of the course the student will be able to apply evidenced based practice across a variety of settings using a clinical reasoning approach.

SYLLABUS

Course Content

Module 1: Principles of palliative care.

Module 2: Communicating with people with life limiting illnesses.

Module 3: Palliative assessment & intervention. Module 4: Optimising function in palliative care.

Course Learning Outcomes

On successful completion of this course, students will be able to:

- 1. Demonstrate advanced understanding of developmental, lifespan, social, spiritual and cultural factors that impact on the quality of life for people with a life limiting illness.
- 2. Critically reflect on their own personal values and beliefs about dying and death and the lived experience of the dying person, their families and communities.
- 3. Demonstrate advanced pathophysiology knowledge to manage common symptoms in the palliative care environment.
- 4. Apply the Roper Logan Tierney Model of Nursing and the Clinical Reasoning Cycle across the lifespan to create a plan of care for individuals experiencing a life limiting illness.
- 5. Critically evaluate the efficacy of pharmacological and nonpharmacological (complementary therapies) in the palliative care context.
- 6. Identify the legal and ethical principles related to caring for people with a life limiting illness.

Course Materials

Required Texts

This course utilises the learning resources of the <u>Palliative Care Curriculum for Undergraduates</u> (PCC4U).

The PCC4U project is a national palliative care project funded by the Australian Government Department of Health and Aged Care. Assessment 1 - Explore concept of grief/loss

Assessment Type

Project

Purpose

The purpose of this assessment is to assist students understand the range of challenges faced by people affected by life-limiting illness using creative art. Creative art such as images, poetry, and music facilitate self-awareness and introspection among healthcare providers, which is important for self-care, empathy, and patient-centred decision-making in palliative care.

Description

The challenges faced by people with a life-limiting illness can be substantial and overwhelming. For this assessment, students will explore common challenges that arise for people diagnosed with life-limiting illnesses by completing three tasks.

- a focused literature review,
- identifying a piece of creative art (images, poetry, or music),
- completing a reflection.

This assessment will assist students to connect to the content taught in modules 1 and 2. Further details this task is provided in Canvas under Assignments tab.

Assessment 2 - Focused Topic

Assessment Type Essay

Purpose The purpose of this assessment is to help students understand the basic principles of

palliative care and its application to real-life care of people with life-limiting illnesses.

Description Providing care for people affected by life-limiting illness requires open communication with

patients and family about the meaning of the illness, associated symptoms, goals of care and clinical management. For this assessment, we are asking students to consider the provided case study available in Canvas and demonstrate their understanding of common symptoms associated with life-limiting illness and the pathophysiology, assessment, management, meaning of the illness and legal issues in palliative care. This assessment will assist students

to connect to the content taught in modules 1, 2, 3 and 4.
