## **OVERVIEW**

Course Description	The main component of the Honours program is an original research project on a topic relevant to nursing/midwifery practice, conducted under the close supervision of an academic staff member. In this course the student will be required to develop and justify search strategies and undertake a search of the academic and professional literature relevant to the research project they are undertaking. They will be required to read, understand and critically evaluate literature
Requisites	This course is only available to students enrolled in the Bachelor of Nursing (Honours) [10954], Bachelor of Midwifery (Honours) [12330] or the Bachelor of Health Science (Honours) [11691] programs.

Develop a search & extraction strategy that includes search terms, & data bases Implement a literature search with data extraction & critique of included studies. 3. Synthesis and presentation of a comprehensive literature review to guide a research 4. thesis. **Course Materials** Available via Canvas
