# **OVERVIEW**

# **Course Description** The advance practice nurse requires diverse knowledge to appropriately and effectively assess and manage patients in an acute care environment. This course builds on the skills, knowledge and leadership of nurses in these settings and includes development of expert, specialised cognitive and technical skills to prepare nurses for advance practice roles in acute care nursing. By the end of the course students will have developed advanced practice skills to enhance the quality and safety of care for people with an acute illness and enhance their ability to influence care outcomes for both individuals and groups of patients within their chosen acute care setting.

# **SYLLABUS**

**Course Content** 

### Topics to be covered include:

- 1. Comprehensive care in Acute Nursing (comprehensive clinical assessment of patients, interpret this clinical data and determine the clinical significance, recognition and current guidelines related to immediate and ongoing care of the patient with deteriorating conditions).
- 2. Acute Nursing Health care systems (theoretical frameworks underlying safety cultures in acute care, Understanding the national model of clinical governance, patient safety and quality improvement including risk management principles and understanding of regulations, policies and procedures that govern practice).
- 3. Acute Nursing professional practice (understanding of different models of care and the impact on professional nursing practice, for example, person-centred care, family-centred care).
- 4. Clinical Leadership in Acute Care environments (Leading and supporting the interdisciplinary healthcare team, enabling change and improving outcomes, and evaluation of the impact nursing leadership has on patient outcomes and the healthcare team).
- 5. Acute Nursing evidence based (research approaches to investigating clinical questions, Evaluating the evidence base in their clinical specialty, developing mastery for implementing evidence-based practices and undertaking policy review within their clinical specialty).

### On successful completion of this course, students will be able to:

- 1. appraise knowledge of acute evidence-based nursing care and integrate into practice to ensure clinical excellence across contexts of acute specialist areas
- 2. compare and contrast contemporary models of care and professional nursing practice issues that support high quality nursing care for acutely ill individuals
- 3. integrate and critically apply knowledge of clinical governance systems (including National Safety and Quality Health Care accreditation standards [NSQHCS] and risk management principles), and legal and ethical frameworks to provide safe, efficient, effective and



culturally appropriate care to acutely unwell individuals

- 4. examine the role of clinical leadership in acute nursing practice and identify personal strategies to enhance your own leadership skills
- 5. develop a practice improvement project across an identified area of acute care nursing practice

### What should be referenced?

All sources of published information including textbooks, journal articles, course readings, websites, guidelines, policies and government documents that have been used to prepare an assessment MUST be included in the assessment as an in-text citation AND on the reference list.

Any documents provided to you to use in the preparation of an assessment must be referenced. Direct quotes MUST be referenced. However, please note direct quotes should be used sparingly and should not constitute more than 10% of an assessment.

Information that you have paraphrased in your assessment must also be referenced. Correct citation of sources and referencing is expected in scholarly writing at Masters level. Assessments that are not correctly referenced may be penalised (lower marks awarded).

### Correct Referencing style

# Assessment 1 - Written Assessment - Australian National Safety and Quality Standards (NSQHS) Gap Analysis

Assessment Type Written Assignment

**Purpose** The focused exploration of the NSQHS standards will lead to a more grounded understanding of the standards and their real-world application. This will lead you to identify any suitable opportunities for practice improvement in line with the standards. This assessment will draw from your understanding of modules 1, 2, 3 & 4.

**Description** Consider the NSQHS as they relate to your own individual practice. For this assessment you will choose any **ONE** of the standards listed below to report on:

- Standard 1 Clinical Governance
- Standard 2 Partnering with Consumers
- Standard 3 Preventing and Controlling Infections
- Standard 4 Medication Safety
- Standard 5 Comprehensive Care



- Standard 6 Communicating for Safety
- Standard 7 Blood Management
- Standard 8 Recognising and Responding to Acute Deterioration

Having chosen your ONE standard, you will prepare a report reflecting on the application of the standard in the following three areas:

- 1. **Strengths / Successes:** Explore and critically discuss how this standard can be applied successfully to improve quality and safety in the acute care setting. This section should include discussion of real-world applications sourced from the evidence and your own clinical practice where appropriate.
- 2. **Weaknesses / Barriers:** Explore and critically discuss any barriers that may prevent or inhibit the success of this standards application. This should include examples from the literature as well as from your own clinical practice where appropriate.
- 3. **Reflection on practice:** Reflect on and discuss how this standard relates to your own clinical practice. Has the standard been well demonstrated through any processes / projects? Are there any opportunities for improvement that you can identify from your practice?

Your report should contain the following sections (with approximate word counts for guidance):

- 1. **Introduction** (100-150 words): a brief introduction outlining the standard you have chosen and the practice context you will be reflecting on. Include a brief rationale for why you have chosen this standard.
- 2. Strengths / Successes (500 words): as above
- 3. Weaknesses / Barriers (500 words): as above
- 4. **Reflection on Practice** (300 words): as above
- 5. Conclusion (100-150 words): A brief conclusion

References should be in APA 7th style.

### **Assessment 2 - Written Assessment – Practice Improvement Project**

Assessment Type	Written Assignment
Purpose	This assessment aims to support and develop your ability to evaluate, interpret and apply high quality evidence in relation to acute nursing practice through the preparation and delivery of a written project proposal.
Description	Drawing on your experience from assessment 1, this task will require you to develop a proposal to implement a practice improvement initiative in your practice context. Within any of the NSQHS standards, you will identify an opportunity for improvement that you will develop into a practice improvement project that could introduced within an acute nursing context of your choosing.
	Once you have identified your chosen improvement opportunity, you will prepare a report



outlining your practice improvement initiative under the follow subheadings:

- Change context (100 words): A brief introduction to the practice context in which your proposal will be completed.
- 2. **Relevant NSQHS standard:** Which standard is identified as being the most relevant to your issue / improvement?
- Background (Problem description) (350 words): Present in detail the problem identified for improvement. Reference existing evidence and appropriate data as necessary.
- 4. **Proposed change / improvement (350 words):** Present in detail the proposed change / improvement you are suggesting addressing the established problem. Reference existing evidence and appropriate data as necessary.
- 5. Leadership considerations (300 words): As the leader of this improvement project, you will discuss any appropriate leadership considerations that may affect the success of your projects implementation. Reference existing evidence and appropriate data as necessary.
- 6. **Barriers and enablers (300 words):** Discuss any relevant barriers or enablers identified that should be considered when reviewing this proposal as it relates to your change practice environment.
- 7. Legal ethical considerations (200 words): Discuss any legal or ethical considerations that are relevant to your proposed change.
- 8. **References:** APA 7th style NB specific care should be taken to avoid self-plagiarism from your first assessment item.

You will be preparing this project proposal from the position of the project leader and as such you should consider and include discussion of relevant leadership issues as required.
