System, clinical, cultural, and interpersonal issues, specific to custodial health, will be examine providing you with the opportunity to develop skills in person-centred, culturally safe care. - 3. Reflect on one's own personal values and attitudes arising when working with people whose behaviour and presentation is challenging and confronting. Identify and resolve ethical dilemmas which specifically arising when working in the custodial environments
- 4. Develop an understanding of the range of diversity within custodial populations and evaluate issues related to cultural safety and vulnerable populations (such as Aboriginal



and Torres Strait Islander people) relevant to the delivery of care in custodial environments

- 5. Demonstrate knowledge of the complexities of delivering quality healthcare in custodial environments
- 6. Discuss the value of interdisciplinary communication and how individual practitioners participate in this process
