Course Description

ORHL3103 builds on the knowledge and skills gained in ORHL1103 and ORHL2105 and provides an opportunity for you to gain an understanding of oral health needs of the Elderly living in the community and in Residential Aged Care Facilities (RACF). During the year you will be rostered in a small group to attend a community placement in one of our participating RACF's and this course will assist you in preparing to attend these placements. This course is a compulsory program component and students must pass in order to complete to the Bachelor of Oral Health Therapy program.

Assessment 1 - Development of an Oral Health Plan

Assessment Type Case Study / Problem Based Learning

Description

Part A:

(15% marks)

Students are required to complete two free online courses from Dementia Training Australia. This assessment is underpinned by self-direction, which allows students to take responsibility and be accountable for their learning. Throughout this assessment, students will extend their understanding of dementia and its impact on their caregivers.

Part B:

During the ORHL3103 workshop students will participate in 3 activities that will initiate the completion of Part B sections i, ii, and iii, of this assessment.



Section i:

(5% of marks)

Students will work as individuals to understand the information provided in the case study. Then students will implement an evidence-based approach to the provision of information and daily care for the patient outlined in the case study.

This task will be submitted as an Oral Health Care Plan, with accompanying references.

Section ii:

(5% of marks)

Students will work as individuals to understand the information provided in the existing oral health promotion intervention. Students will critically evaluate the intervention provided, and then provide a 300-word reflection on the positive aspects of the intervention. Students will then outline one significant (evidence-based) change they would implement if given the opportunity (100-words).

Section iii

(5% of marks)

Students will work as individuals, whilst reviewing the provided scientific research poster. Students will use the rubric provided, to allocate a justified mark for the poster provided. Students will then provide feedback in the comments (100 words only). The data collection methods, collation of the data, and the analysis of the data obtained from oral health indices or other research methods must all be mentioned in the feedback provided.

Description

Students must highlight on the cover page if their reflections are being completed pre- or post-placement.

Provide a 300-word reflection on each of the following topics:

- 1) Current debates on the provision of general and oral health care within the community and society
- 2) Benefits and limitations of teamwork
- 3) Ageism

Assessment 3 - Peer Discussion and Review

Assessment Type Peer to Peer Learning Activity

Description Students will be paired with one/two other student.

The pairing will be coordinated based on pre (has not been on placement) or post (has been on placement) attendance at the time of authorizing of Accessment 2.

on placement) attendance at the time of submission of Assessment 2.

For example, if a student (1) submitted a pre-placement Assessment 2, they will be paired with a post-placement student (2).

Five groups of students may be paired as a trio.

In pairs, students will engage in a peer review process, comparing and contrasting their reflections from Assessment 2 under the following headings:

Current Debates on the Provision of General and Oral Health Care within the Community and Society:

Reflect on the key points discussed in each other's reflections regarding current debates on the provision of general and oral health care.

Identify areas of agreement and disagreement and provide constructive feedback on the depth of analysis and critical insights presented.

Benefits and Limitations of Teamwork:

Compare and contrast each other's reflections on the benefits and limitations of teamwork in oral health settings.

Evaluate the effectiveness of the arguments presented and provide suggestions for further exploration or refinement.

Ageism:

Analyze each other's reflections on the concept of ageism and its implications for oral health practice.

Offer alternative perspectives or additional examples to enhance understanding and awareness of age-related issues in healthcare.

Placement Attendance records must be collected by each student from the Peninsula Village placement supervisors. This document needs to be then scanned and submitted with Assessment 3 via Canvas. Failure to provide a record of attendance in this manner will result in an instant failure of the course.


