OVERVIEW

Course Description

Interviewing and assessment is a key component of many areas of professional practice relevant to the discipline of psychology, such as research, forensic settings, disability services, early intervention and various organisations. This course will familiarise students with the theoretical foundations of psychological interviewing and assessment across multiple settings relevant to the discipline. Students will further develop their understanding of the strengths and limitations of a range of assessment tools and methods. Students will learn about interpersonal communication and interview skills and the practical applications of these in multiple areas of applied psychology. Students will gain an understanding of the psychology profession Code of Ethics and the ethical and cultural considerations for interviewing and assessment in real-world settings.

The course forms part of a sequence of courses that have been approved by the Australian Psychology Accreditation Council (APAC).

This course is only available to students enrolled in Bachelor of Psychological Science (Honours)[40100], Bachelor of Psychology (Honours) [12362], or Bachelor of Science (Honours) [10496].

Assessment 4 - Skills Demonstration and Written Report

Assessment Type	Professional Task
Purpose	To develop skills in interpersonal communication and interview skills in situations appropriate to psychological assessment. To reflect on interviewing in assessment-related settings. Course outcome 3.
Description	Presentation (10%): Students will conduct an interview in the context of a brief assessment-related context. Reflection (25%): Students will write a reflection on their ability to demonstrate the APAC core competencies in interpersonal communication and interview skills and the challenges involved (including ethical issues).
Weighting	35%
Length	Presentation 5 min. Written reflection 1200 words. Word limits include headings, sub-heading, in-text citations, quotes and referencing but does not include the list of references, appendices, and footnotes. The word limit will allow a tolerance of 10% and any work after the maximum word limit will not be included within the allocation of marks. In other words, the marker will STOP reading at 1320 words
