

The Thesis mark will be further broken down as follows.
Student Intellectual contribution to the project - 50% Amount of work performed by the student - 20% Report/Thesis presentation - 10%

The USB should be clearly labelled and structured so that it is easy to locate and read all the information stored on the USB.
