OVERVIEW

Course Description	This online course focuses on high level ethical decision making relating to individual, group and community practice. It runs parallel to SWRK3300:Field Practicum. Students will be required to integrate and critique theoretical models and decision making tools relevant to their practicum field of practice.
Requisites	To enrol in this course students must be active in the Bachelor of Social Work (Honours) (12317), and have successfully completed SWRK2001, SWRK2003, SWRK2005, SWRK2200 and have successfully completed or be concurrently enrolled in SWRK3300.

Course Content	<ul style="list-style-type: none">• Ethical theories and perspectives.• Ethical decision making frameworks and models and their application in social work practice.• Ethical decision making processes and practice responses to a diverse range of client presenting issues.
Course Learning Outcomes	<p>On successful completion of this course, students will be able to:</p> <ol style="list-style-type: none">1. Formulate an advanced awareness of their personal and professional values and how these impact on ethical decision making, and a capacity to appraise these values with reference to the requirements of professional practice.2. Demonstrate a high level of self-awareness and open transparent decision-making that integrates and is responsive to feedback from clients, peers, supervisors and teaching staff3. Incorporate a critical understanding of the application of the AASW Code of ethics and knowledge of a range of perspectives and theoretical frameworks that influence ethical decision making in practice4. Develop and apply knowledge from a range of ethical frameworks, models and approaches to assessment and intervention with clients, paying particular attention to work with people from culturally, linguistically and spiritually diverse backgrounds5. Develop a capacity to search for, analyse and present relevant literature in relation to ethical social work practice and specific issues related to social work practice.

Assessment 1 - Case Study/Problem Based Learning

Assessment Type Case Study / Problem Based Learning

Purpose Demonstrate familiarity with, and use of, the AASW Code of Ethics, its components and uses, and to identify ethical issues in day to day social work practice.

Description This task is split into two components, each worth 15%. Each task has the same format where you are asked to identify and define one ethical issue that you identify from an on-line panel discussion. The panel will include experienced social work practitioners situated in different settings. Each panel will discuss ethical issues that are experienced in day to day practice and the members are likely to have a range of experiences and views. The panels will be held the week before the assignment is due.

1. Situate the practice approach presented in a relevant theoretical framework.
2. Explain why you agree or disagree with the treatment of the ethical issue described by the practitioner.
3. Use the AASW code of ethics to further support your justification and analysis.

Suggested approach: These two assignments are short pieces, at only 750 words, and as such need to be written in a professional and concise manner. You may use dot points to list items and headings where that is suitable to progress your argument.

Using the ethical issue that you identified, describe its nature and dimensions. Choose a theoretical approach/s that you have learnt about in this course that you think best reflects the approach to practice you heard being described. Was this the correct approach or not?

Apply your knowledge using one or more theories/ approaches to assist you to analyse the issues and how to deal with them. Analyse if / how the practice approach relates the AASW Code of Ethics.

Assessment Criteria	<p>1. Ethical issue recognition: Student can recognise ethical issues when presented in a complex, multilayered practice context AND can recognise cross-relationships among the issues</p> <p>2. Connecting theory and practice: Students employ a formal, structured thought process attending to contra or complementary stakeholder and theoretical perspectives. Students argue with evidence (professional framework from the AASW Code of Ethics and theoretical frameworks from scholarly journals) to provide justification and analysis.</p> <p>3. Clarity of written communication: Students clearly and succinctly express ideas in a writing that is suitable for a professional audience. Cited evidence follows APA format.</p>

Purpose	Development of a Professional Development module for ethical decision making that is suitable for use in your placement
Description	<p>You must design an ethical decision making model that is adapted to your organisational context.</p> <p>Provide a diagram to communicate your model, and rationale for your design.</p> <p>The ethical decision making model that you develop needs to:</p> <ul style="list-style-type: none">• be capable of guiding the user through a process of ethical considerations and decision making in this professional setting.• take into consideration the legislation, policies and practice guidelines that apply to this setting.• refer to the professional guidelines provided by the AASW Code of Ethics, and• consider if there is a body of knowledge about the issue that needs to be considered• provide a step-by-step process working through an ethical issue to arrive at a conclusion.

Assessment 3 - Ethical Decision Making

Assessment Type	Written Assignment
Purpose	Application of an ethical decision-making model to a case study.
Description	<p>For this task, you will undertake an ethical analysis of a case study from either your placement or other professional social work setting to an ethical decision making process. You may use the ethical decision making process that you have developed or you may apply another model suitable to your context. The case study that you choose may be</p>

from the range of social work practice for example, management, community work, advocacy, research or policy, or direct work with an individual or families.

Your assignment should entail:

The application of an ethical decision making model/process must:

- Description of relevant features and presenting issues in the case study
- Identification and critical exploration of ethical values and principles that are relevant, with particular reference to AASW Code of Ethics
- Research and literature that informs the situation
- Personal reactions and reflections about the use of the process that you adopted.
