Frequently Asked Questions

Does this change what I need to enrol in?

No. You still need to complete 20 units of core courses, a 10 unit Group A directed course, and a 10 unit Group B directed course. If you have completed a Group A directed course or Group B directed course that is no longer offered, it will still count towards your program.

Can I still complete my program?

Yes, you will still be able to complete your program.

Will this delay my graduation?

No. As the changes do not increase the total number of courses you need to complete, these changes will not delay your graduation.

Can ENVS6001 count as my Group A directed course and my Group B directed course?

No. ENVS6001 can count as either your 10 unit Group A directed course or your 10 unit Group B directed course but it cannot count as both.

I have completed a course that is no longer offered, will it still count towards my program?

If you have completed a Group A directed course or Group B directed course that is no longer offered, it will still count towards your program.

Is the Master of Environmental Management and Sustainability still available?

From 2021 the Master of Environmental Management and Sustainability has been updated and there is a new program code – 40275. Students who intend to apply for the Master of Environmental Management and Sustainability should review the updated program structure here:
