There are changes to the **Criminology Major** within the Bachelor of Social Science effective Semester 2, 2023.

10 units have been added to the compulsory course list and 10 units have been removed from the directed course list.

CRIM2001 has been removed from the directed course list and added to the compulsory course list.

Several courses have also been removed from the directed course list, detailed in the table below.

Transition Arrangements

Students who have successfully completed CRIM2001 as a directed course will have this towards count program requirements. These students are required to complete 80 units combined from the compulsory course and directed course lists.

Students who have not successfully completed CRIM2001 and who have not satisfied the 2000 level directed course requirements, are required to complete CRIM2001.

Students who have not successfully completed CRIM2001 however have satisfied the directed course requirements, are not required to complete CRIM2001. As CRIM2001 is assumed knowledge for CRIM3002, these students are required to contact the Course Coordinator of CRIM3002 for further information.
